CONDITIONS FOR ENROLLMENT

1. The undersigned, his/her family and guests agree to abide by the rules and regulations set forth by the camp for the health, safety and welfare of all Campers.
2. Due to the fact that all camping programs are planned in advance to the opening of Camp, including purchasing of campers' supplies, equipment and hiring of personnel, and are based on confirmed Camper reservations, no allowances, refunds or rebates can or will be made if **cancellation occurs after January 31st**.
3. The Camp reserves the right to dismiss a Camper whose **conduct or influence is unsatisfactory**, or, in the opinion of the Camp Director, not in the best interest of the Camp and, in that event, there shall be **no refund of any part of the tuition.**
4. The Camp is not responsible for articles of clothing or personal belongings lost or damaged by fire, theft or laundering.
5. In case of medical or surgical emergency, we hereby give permission to the physician selected by the Camp Director to hospitalize and secure proper treatment for any member of our family. All such expenses will be the responsibility of, and shall be paid by, the individual.
6. We agree to complete and submit a health form for all minors at least two weeks prior to Campers' arrival at camp. Forms will be provided prior to camp, and we would like to request their prompt return as soon as possible.
7. The undersigned consents to the use of any pictures, addresses, and phone numbers of family members for the purpose of Camp Rosters, advertising or promotions.
8. I/We understand and acknowledge that certain activities provided by the Camp (including, but not limited to, horseback riding, waterskiing, sports, ropes course, etc.,) have an increased risk of injury. I/We further acknowledge and state that I/We will assume full responsibility for my/our family's safety and hereby agree to release and indemnify Western Camps, Inc., Wonder Valley Family Camp, and all of their officers, employees, agents and representatives whatsoever, from any claims, cost, expense, including attorney's fees and or damages which any of them may incur arising from our Family's participation in such activities.
